**2.0 USES**

The Western red cedar shakes are wood roof covering materials for use where the IBC and IRC permit nonclassified roof coverings.

**3.0 DESCRIPTION**

The Western red cedar shakes (nonpreservative-treated) are manufactured in accordance with the grading rules specified in Section 1507.9.6 of the 2009 IBC, Section 1507.9.5 of the 2006 IBC and IRC Section R905.8.5.

**4.0 INSTALLATION**

The Western red cedar shakes must be installed in accordance with IBC Section 1507.9 or IRC Section R905.8, as applicable.

**5.0 CONDITIONS OF USE**

The Western red cedar shakes described in this report comply with, or are suitable alternatives to what is specified in, those codes listed in Section 1.0 of this report, subject to the following conditions:

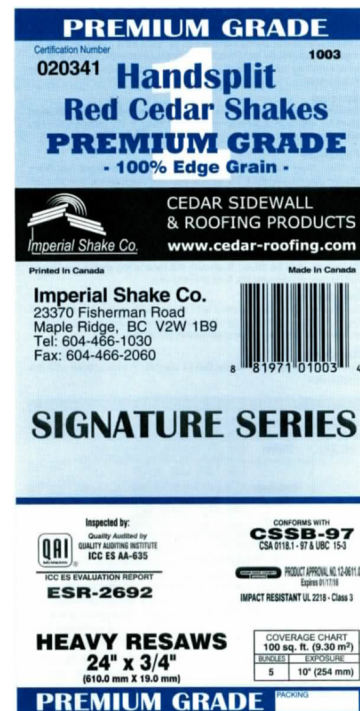


FIGURE 1—PRODUCT LABEL

- 5.1 Products must be identified as noted in Section 7.0 and shown in Figure 1 of this report.
- 5.2 Products are manufactured at 23370 Fisherman Road, Maple Ridge, British Columbia, Canada, under a quality control program with inspections by ICC-ES.

5.3 The products must be installed as noted in Section 4.0.
